27 Whereas an Amended Petition for Appointment of Commissioner as Receiver and  
28 Other Permanent Relief; Request for Temporary Injunction pursuant to NRS 696B.270(1)  
("Petition") was filed in the above entitled Court initiating these proceedings, and;

GOOD CAUSE APPEARING, IT IS HEREBY ORDERED that pursuant to NRS  
696B.270(1), the Commissioner of Insurance for the State of Nevada, Scott J. Kipper, is  
appointed as a Temporary Receiver of NEVADA CONTRACTORS INSURANCE COMPANY  
INC., a Nevada Domiciled Captive Insurance Company ("NCIC") and BUILDERS

1 INSURANCE COMPANY INC., Nevada Domiciled Property and Casualty Insurance Company  
2 ("BIC") (hereinafter "Insurers") pending further orders of the Court.

3 IT IS FURTHER ORDERED that pursuant to NRS 696B.270(1), pending the show  
4 cause hearing and further orders by the Court, Insurers, all officers, directors, stockholders,  
5 members, subscribers, agents, employees, and all other persons, except the Receiver or any  
6 person or persons designated by the Receiver, are immediately enjoined from transacting any  
7 further business on behalf of the Insurers or wasting or disposing of any assets or property of  
8 Insurers.

9 IT IS HEREBY FURTHER ORDERED that pursuant to NRS 696B.270(1) and  
10 696B.340, pending the show cause hearing and further orders by the Court, all persons are  
11 hereby immediately restrained from the commencement or prosecution of any actions by or  
12 on behalf of the Insurers or against the Insurers. All persons are hereby restrained from  
13 obtaining any preferences, judgments, attachments, or other liens as to any property of the  
14 Insurer, or making any levy against the Insurer or against its assets or any part thereof.

15 IT IS HEREBY FURTHER ORDERED that pursuant to NRS 696B.270(1), pending the  
16 show cause hearing and further orders by the Court, all persons other than Receiver are  
17 hereby enjoined from withdrawal of any funds from Insurers" accounts, or removal of other  
18 property from Insurers.


