21	The matter of final approval of the Proposed Plan of Distribution to Estate Claimants of	
22	Nevada Contractors Insurance Company, Inc. came on for hearing before the Court on Octobe	
23	19, 2020. The Court was advised that settlements	had been reached with respect to any remaining

disputed claims and that no objections had been received concerning the proposed plan of distribution after notice to the claimants. No supplemental notice was deemed necessary as any

settlements that had been reached would not negatively affect other claimants in the particular class of distribution (given the sufficiency of assets to pay all claims in the particular class and given the reserves that had been set aside pursuant to the Motion for Preliminary Approval filed on May 22, 2020, which was granted on June 26, 2020).

IT IS HEREBY ORDERED that the final proposed plan of distribution is approved including:

- The distribution of payments in full from NCIC to those claims whose claims A. had been adjudicated by the SDR both as to an amount certain, and as to falling within the statutory distribution priorities specified in NRS 696B.420(1)(B) through 696B.420(1)(F).
- B. The distribution of payments from NCIC, pro rata, to those claimants whose claims had been adjudicated by the SDR both as to an amount certain, and as to falling within the statutory distribution priorities specified in NRS 696B.420(1)(G).
- C. Approval of the Special Deputy Receiver's BIC claim determination against NCIC as set forth in the Motion for Preliminary Approval. Subject to the reserves for expenses and contingencies for further wind-down, BIC's claim shall be paid after the payment of all other NCIC approved claims. After final wind-down of NCIC, any remaining reserve funds of NCIC will be paid to BIC in further payment of BIC's claim.
- D. Approval of the Special Deputy's reserve as set forth in the Motion for Preliminary Approval for expenses and contingencies in connection with further winding-down of the NCIC receivership.
